

# 1. Scope of Work

The scope of work includes dismantling of old damaged sanitary and plumbing fittings and providing, fixing, testing and commissioning of new sanitary, plumbing and civil items including complete labour, material, tools & plants, transportation and all incidental works required for proper completion of work.

The detailed scope includes but is not limited to:

- Replacement of existing CPVC water supply pipe lines with fittings and accessories.
- Replacement of existing GI & PVC waste and soil pipe lines from source to chamber.
- Chase cutting, wall/floor opening, underground pipe laying and restoration work.
- Providing and fixing of WC Indian type pan with flushing cistern.
- Providing and fixing of wash basin with CP fittings and accessories.
- Providing and fixing ceramic wall tiles and anti-skid floor tiles.
- Repairing of inspection chamber including connection with existing chamber.
- Painting of toilet block walls with oil bound distemper.
- Disposal of dismantled/unserviceable material from site as per instruction of available authority.
- Any other miscellaneous item required for successful completion of work shall be deemed included in contractor's scope.

### 4. Eligibility Criteria

The contractor should have experience of similar nature works such as sanitary, plumbing, toilet renovation, pipe line work, civil repair and allied maintenance works in Government/Semi Government/Institutional buildings.

### 5. Completion Period

The work shall be completed within **45 days** from the date of issue of work order.

### 6. Defect Liability Period

The contractor shall be responsible for any defect/leakage/poor workmanship observed during a period of **06 months** from the date of completion of work.

### 7. Terms & Conditions

1. Rates shall include cost of all materials, labour, T&P, transportation, taxes, loading/unloading and all incidental charges.
2. Dismantled unserviceable material shall be disposed of by the contractor outside the campus with permission of available authority.
3. Necessary cutting/chasing/opening in wall and floor and restoration finishing work shall be included in quoted rates.
4. The work shall be executed as per directions of available authority.
5. Only approved quality material shall be used after approval from concerned In- Charge.
6. No extra payment shall be made for minor miscellaneous items required for successful completion of work.
7. Contractor shall maintain proper safety and cleanliness during execution of work.
8. Measurement shall be taken on actual executed quantity basis.
9. Payment shall be made on satisfactory completion of work on floor wise basis of each block after verification and satisfactory report received from Principal I/c KCON.
10. The financial bid is for 1 pair of toilet and bathroom and its common gallery, rate quote is for one pair same this process includes first for one block each block contain 12 such pair 6-6 on each floor. First stage we will have it for 2 block later the quantity will increase or decrease.

## **8. Security Deposit**

Security Deposit equivalent to 10% of the Work Order value shall be deposited by the successful bidder in favour of BSM. The Security Deposit may be deposited separately or may be recovered from the running/final bills of the contractor, as decided by the Institute. The Security Deposit shall remain with BSM for a period of 06 (Six) months from the date of satisfactory completion of work and shall be released thereafter subject to satisfactory performance of the work and certification by the Principal I/c KCON.

## **9. Validity of Rates**

Rates quoted by the contractor shall remain valid for a period of 90 days from the date of opening of tender.

1. The bidder should be a registered contractor having experience in similar nature of works such as sanitary, plumbing, toilet renovation, pipe line laying, chamber repairing, civil maintenance and allied works.
2. The tender must be accompanied by Earnest Money of **Rs.18050.00** The same can be deposited either by Cash or Demand Draft in favor of BSM A/C of Kasturba College Of Nursing Bhopal (Acc No 10022106292) and shall be returnable to every unsuccessful tenderer.
3. The Contractor is required to prepare two sealed cover super scribed as (i) Cover-I Technical Bid, and (ii) Cover-II Financial Bid. Both covers should be kept in one main sealed cover as " For Renovation of Toilet & Bathroom Fittings including Pipe Line, Chamber Repairing and Allied Civil Works at KCON Hostel."
4. The tenderer has to submit the cover sealed in above manner at BSM Office P&S section or before as the date mentioned above positively. The tender shall not be accepted beyond the stipulated date and time under any circumstances whatsoever.
5. The Technical bid will be opened on the same day at 16:00 Hrs by the tender Committee of BSM, in its office in the presence of the tenderers of the authorized representative who wish to be present. The date and time for opening of Financial Bids of the technically qualified tenderers shall be communicated later as per convenience of this office.
6. Bidders shall not approach for refund of EMD till the finalization of the tendering process and award of supply the items to qualifying tenderer. The offer should remain valid for a minimum period of 90 days. EMD shall be refunded to the unsuccessful bidders within 30 days of award of contract to the successful bidder/bidders.
7. BHEL Shiksha Mandal reserves the full rights to increase/decrease the quantity of items in the tender as per requirement.
8. In all cases of dispute, the decision of the President, BHEL Shiksha Mandal shall be final and binding on both the parties.
9. Materials should be of best quality and to our specifications. Materials not confirming to these shall be rejected and returned to the supplier at their own risk and cost.
10. The bidder should have successfully completed work experience of not less than -:
  - Three similar completed works each costing not less than Rs 360598.
  - OR**
  - Two similar completed works each costing not less than Rs 540898.
  - OR**
  - One similar completed work costing not less than Rs 721197.
11. The bidder should have valid:
  - GST Registration Certificate
  - PAN Card
12. The bidder should have average annual financial turnover of at least Rs275000/- during the last three financial years.
13. The bidder should not have been blacklisted/ debarred by any Government Department, PSU, Autonomous Body or Institution. A self-declaration in this regard shall be submitted.
14. The agency should inspect the site before quoting the rates and no extra claim on account of lack of site knowledge shall be entertained later.
15. The contractor shall arrange all required tools, materials, plants, labour, safety equipment and transportation at his own cost for successful completion of work.
